Before submitting a quality company incorporation application to the <u>New Zealand</u> <u>Companies Office</u>, our Staff and Client will detail-discuss the business set up considerations on <u>this webpage</u>; and



- 2. The <u>Companies Act of 1996, Section 186</u> stipulates that each local entity must maintain a legal registered office in New Zealand. As always, Healy Consultants Group PLC will supply this <u>professional service</u>; and
- The <u>Companies Act Amendments of 2014</u> stipulates that each New Zealand LLC must have at least one individual director ordinarily resident in New Zealand. As always, Healy Consultants Group PLC will supply our Client with a professional passive nominee <u>resident director</u>; and
- 4. Healy Consultants Group PLC will secure multi-currency corporate bank/PSP account numbers for our Client's company. It will take on average <u>two months</u> to secure an international corporate bank/PSP account from the moment a complete quality corporate bank/PSP account opening application is submitted to the banks. In most cases, we can secure corporate bank/PSP account numbers without our Client's travel to bank's branch. When travel is unavoidable, we refund US\$950.

- b. Optimize the use of i) tax exemptions and ii) Government incentives and iii) foreign tax credits and iv) double tax treaties; and
- c. Prepare annual financial statements and annual corporation tax return and submit them to the IRD; and
- d. Secure a legal exemption from independent statutory annual audit;
- e. For a dormant Turkish LLC, our fees are only <u>US\$ 1,200</u>. Our Client must email us bank statements as evidence of the same;
- 8. All fees quoted in this invoice correspond to fees quoted <u>on Healy Consultants Group PLC' website</u>. Please review this invoice carefully to identify errors.
