1. 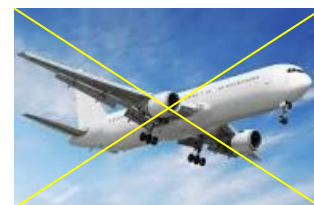

Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

4. This fee is an estimate of Government costs to complete your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include **i)** reserving the company name; **ii)** annual license fees; **iii)** paying the Chamber of Commerce fee; **iv)** notarize all documents of the company we are registering in UAE; and **v)** the specimen signature and the Board of Resolution preparation and submission fee;
