### Notes to invoice above

1. Within [two weeks](#) from receipt of engagement fees and signed documents, Healy Consultants Group PLC will complete Hong Kong branch registration. Before submitting a branch office formation application to the [Companies Registry](#), our Staff and Client will detail-discuss the important business set up considerations, detailed on [this webpage](#) (click link) and this [webpage](#); and
2. In accordance with [Hong Kong New Companies Ordinance](#), all Hong Kong branch offices must maintain a legal registered office address in the country. As always, Healy Consultants Group PLC will supply [this professional service](#); and
3. This fee is an estimate of Government costs payable during your Firm's engagement. For transparency purposes, all Government fee payments will be supported by original receipts and invoices; and
4. The [Hong Kong New Companies Ordinance](#) stipulates that all branches of foreign companies registered in Hong Kong must appoint a resident authorized representative. Most of our Clients request our Firm to supply them with a [nominee professional passive Hong Kong resident representative](#); and
5. Healy Consultants Group PLC will secure Hong Kong multi-currency corporate bank account numbers for our Client. From the moment a complete application is submitted to the banks, it will take on average [two months](#) to secure multi-currency corporate bank account numbers. Unfortunately, all Hong Kong banks require a face-to-face meeting with the authorized signatories at their Hong Kong branch. Alternatively, Healy Consultants Group PLC can secure an alternative banking solution outside of Hong Kong: in most cases, our Staff will then complete the engagement without our Client's travel to the bank branch. When [travel](#) is unavoidable, we refund US\$950 to our Client. Multi-currency corporate bank account opening is the most [challenging](#) part of the engagement. Consequently, we apply our "[guaranteed bank account approval or your money back](#)" policy.




To minimize engagement surprises and align all parties' expectations, I recommend you read [this webpage](#), specially the due diligence documentation section. To maximize the probability of bank approvals, Healy Consultants PLC will:

- ✓ prepare a business plan, including annual expected inflow and outflow of funds; and
  - ✓ contact multiple banks to secure their written confirmation, welcoming a formal multi-currency corporate bank account opening application; and
  - ✓ weekly follow up with the bankers to aggressively and skilfully secure a timely multi-currency corporate bank account approval.
6. For a Hong Kong Branch office, this is [an estimate](#) of Healy Consultants Group PLC's fees to timely accurately and completely discharge our multi-national Clients' annual legal, accounting and tax obligations.
