

The life of the Representative office is limited to the life of the parent company;
- 15. According to Turkish Commercial Code, i) each director is personally liable for all and any company's public debts and ii) at least one director must be appointed as shareholder;
- 16. If our Client requires nominee shareholder and director <u>services (click link)</u>, Healy Consultants Group PLC will be pleased to assist. Our fee to be nominee resident director or shareholder amounts to €13,600 per annum. Our fee for professional, passive nominee corporate non-resident shareholder amounts to €3,100 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants Group PLC to reputation, litigation and financial risk;
