

If required, Healy Consultants will be pleased to provide your firm with a professional nominee representative in Kazakhstan. Our fee amounts to US\$6,600 per annum;

Furthermore, every bank signatory of a Kazakhstan corporate bank account must hold a Kazakhstan work visa. Consequently, we recommend our Clients' to appoint a resident representative who will also be the bank signatory. If required, Healy Consultants Group PLC will help our Client secure a Kazakhstan work visa for our Client within 2 months;

13. If our Client and Healy Consultants properly plan this engagement, our Clients will <u>not</u> have to travel during this engagement.
