Thereafter, this address will be used to receive government correspondence including i) tax letters ii) notice of the legal annual return; and iii) all government communications. - 3. Healy Consultants Group PLC will be pleased to open an Ethiopian corporate bank account without travel. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Bank of Abyssinia, Bank of China, ANZ bank, Standard Bank, UBS, Credit Suisse;

The banks enjoy ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC' control. What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. - 5. In accordance with Ethiopia Taxation Laws, each entity must register for corporate tax and VAT at the <u>Ethiopian Revenues And Customs Authority;</u>

Following receipt of a set of draft accounting numbers from your branch, Healy Consultants will more accurately advise accounting and tax fees. - 9. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants Group PLC realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants Group PLC completes the engagement faster and more easily than expected, Healy Consultants Group PLC is happy to refund some fees to our Client;

- 11. In accordance with <u>Ethiopian Commercial Code</u>, a capital of US\$200,000 must be deposited to the company bank account at incorporation for a branch of a foreign company. This capital must be redeposited into the account to renew the license every year. To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these funds on behalf of our clients;
- 12. In accordance with the <u>Ethiopian Commercial Code</u>, each Ethiopian branch must have at least one individual country representative ordinarily resident in Ethiopia. If required, Healy Consultants will be pleased to provide your firm with a professional nominee representative in Ethiopia. Our fee amounts to US\$6,600 per annum;
- 13. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients' will <u>not</u> have to travel during this engagement. Healy Consultants Group PLC will efficiently and effectively and aggressively complete branch registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to i) sign and get documents legalized in the embassy in their country of origin and ii) courier the originals to Healy Consultants Group PLC office;



14. Depending on our Client's business and nationality, the Ethiopian Government may require a special regulatory license to carry on your business in the country. Healy Consultants Group PLC will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of company registrations and business licenses;

- 15. Branches if foreign companies are allowed to establish business activities within all sectors open to foreign investment. The branch suffers a corporation tax of 30% with an additional remittance tax of 10%. A branch can i) lease office premises ii) issue sales invoice to Clients' and iii) sign local legal contracts. A branch can import and export goods. The life of the branch is not limited.
- 16. If required, Healy Consultants Group PLC will be pleased to assist your firm to secure employee visa approvals. Our fee is US\$3,950 for the first employee, US\$2,950 for the second employee, US\$1,950 per employee thereafter. Our employee visa fees include preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC' control. What is inside our control is the preparation and submission of a high-quality immigration visa application that maximizes the likelihood of visa approval;
