Healy Consultants Group PLC will act as your Massachusetts company agent, our annual responsibilities include **i)** preparing and filing the legal annual return; **ii)** securely maintaining company records; **iii)** liaising with the government on our Client's behalf; **iv)** legal filing of changes of company structure and **v)** reminding our Client of statutory deadlines;

In accordance with [Massachusetts Limited Liability Company Act](#), an LLC shall as from the date of its incorporation have a legal registered office in Massachusetts, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC's Massachusetts office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters; **ii)** notice of the legal annual return and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants Group PLC's office address](#) on invoices, contracts, websites and business cards;

3. This fee is an estimate of government costs payable during your firm's engagement. All government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the [company name](#); **ii)** submitting the [company incorporation forms](#) and **iii)** applying for a Certificate of Good Standing. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;

What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. Furthermore, all companies which wish to sell tangible property in Massachusetts must [register for sales tax](#). Healy Consultants Group PLC will be happy to assist you with registration for corporate tax and sales tax for a one-time fee of US\$750;
6. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations.
