A RO can i) lease office premises but cannot; ii) issue sales invoice to Clients; nor iii) sign local legal contracts. A RO cannot import and export goods. The life of the RO is limited to that of the parent company
- 11. Engage Healy Consultants Group PLC to <u>project manage</u> business set up in every country on the planet. We are the best in the <u>world</u> at what we do, timely completing the A to Z of every country engagement;
- 12. Depending on our Client's business and nationality, the Myanmar Government may require a special regulatory license to carry on your business in the country. If required, Healy Consultants will be pleased to provide your Firm with a professional nominee local representative in Myanmar. Our fee amounts to US\$6,600 per annum;
- 16. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients will <u>not</u> have to travel for a Myanmar registration process.
