What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement; This fee is an estimate of Government costs to complete your Firm's engagement.

- 4. This fee is an estimate of Government costs to complete your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. - 10. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants Group PLC realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees;

- 13. According to UAE company law, a UAE national is required to a share of at least 51% in a UAE JSC. In addition, the majority of directors and the Chairman must be UAE nationals. Healy Consultants Group PLC will be happy to act as nominee shareholder, director or Chairman for your UAE JSC. To ensure your assets are fully protected, the nominee will not be a bank signatory, nor will he have an active role in daily corporate activities. Our fee for the same will be US\$10,800 per annum as published on our <u>website</u>. Upon further understanding of your business activities, Healy Consultants Group PLC will accurately advice on local agent sponsor fees;
- 14. In accordance with UAE Company Law, the issued share capital of a Private JSC amounts to US\$545,000,000 (AED2,000,000) and the one of a Public JSC is US\$2,723,000 (AED10,000,000) and must be deposited to the company bank account. To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these funds on behalf of our clients;
- 15. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients will <u>not</u> have to travel during this engagement. Healy Consultants Group PLC will efficiently and effectively complete company registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to i) sign and get documents legalized in the embassy in their country of origin and ii) courier the originals to Healy Consultants Group PLC office;

Consequently, our Client should budget for possible additional translation and embassy atestation fees. Either our Client or Healy Consultants Group PLC can complete this administrative task;
