Healy Consultants' fees to efficiently complete Philippines ROH registration within <u>ten weeks</u> by i) choosing the optimum regulatory license for our Client's business activities; ii) reserving a ROH name with <u>Securities and Exchange Commission</u> (SEC); iii) settling our accountant and lawyer fees and iv) preparing a high quality ROH registration application for <u>SEC</u>;

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a <u>detailed project plan</u>, mapping out <u>deliverables</u> by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a <u>detailed status</u> <u>update</u>. Our Client is immediately informed of engagement problems together with solutions. Healy Consultants will be the Philippines resident agent for our Client and our annual responsibilities include i) preparing and filing the legal annual return; ii) securely maintaining ROH records; iii) liaising with the Philippines government on our Client's behalf; iv) legal filing of changes of ROH structure; and v) reminding our Client of statutory deadlines;
- 3. This fee is an estimate of Government costs payable during your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include i) reserving the ROH name with the <u>Securities and Exchange Commission</u> (SEC); ii) preparation of ROH documentation with Securities and Exchange Commission (SEC); iii) registration with the local Government Units (Barangay, Mayor's Office) where your business is located and iv) registering the ROH with the <u>Bureau of Internal Revenue</u> and Social Security System. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

4. Healy Consultants will be pleased to open a Philippines bank account for the ROH without our Client needing to travel. It is a time consuming task, Healy Consultants will shelter our Client from the administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed ROH, when the parent company and directors and bank signatories reside overseas. Healy Consultants will prepare a business plan for the bank to optimize the probability of ROH bank account approval. Depending on our Client business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Philippines for ROH bank account opening, Healy Consultants will refund our Client US\$950;

If our Client is not comfortable with only a Philippines ROH bank account, Healy Consultants will be pleased to open <u>an international ROH bank account</u> (click link) outside of Philippines. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

The banks enjoy ultimate power of approval of ROH bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality application; maximizing the probability of approval. To date, we enjoy 100% approval record because of <u>our global banking relationships</u> and our determination;

Global banks continue to tighten ROH bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the ROH bank account will be, including sales contracts or lease agreement;

- In accordance to the Philippines <u>Tax Code</u>, each ROH must register for tax at the <u>Bureau of</u> <u>Internal Revenue</u>. The annual sales threshold for VAT registration is PHP 1,919,500;
- 6. For an active trading ROH, these <u>accounting and tax</u> fees are an estima Healy Consultants fees to efficiently and effectively discharge your an ROH accounting and tax obligations. Following receipt of a set of accounting numbers from your ROH, Healy Consultants will more accura advise accounting and tax fees. For a dormant ROH, Healy Consultants are only US\$950;



7. - 10. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster and more easily than expected, Healy Consultants is happy to refund some fees to our Client;
- 11. Engage Healy Consultants to <u>project manage</u> business set up in every country on the planet. We are the best in the <u>world</u> at what we do, timely completing <u>the A to Z</u> of every country engagement;
- 12. In accordance with <u>Philippines Company Law</u>, the issued share capital of US\$200,000 must be deposited to the company bank account. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our clients;
- 13. Before ROH registration is complete, the Philippines Government must review and approve a lease agreement for office premises. If your Firm requires this service from Healy Consultants, our one-time fee amounts to US\$950. The monthly rent thereafter will be paid independently and directly to the landlord by our Client. An estimate of such a rental for a shared office space for one person amounts to US\$350 per month;



14. If our Client and Healy Consultants properly plan this engagement, our Clients' will <u>not</u> have to travel during this engagement. Healy Consultants will efficiently and effectively and aggressively complete ROH registration and ROH bank account opening in a timely manner without our Client presence. Instead, our Client will need to i) sign and get documents legalized in the embassy in their country of origin and ii) courier the originals to Healy Consultants office;



- 15. ROH is a branch of a foreign company that can exclusively offer services to their affiliates, branches or subsidiaries. ROH's business activities are limited to i) general administration, planning and coordination; ii) sourcing and procurement of raw materials and components; iii) corporate finance advisory services; iv) marketing control and sales promotion; v) training and personnel management; vii) logistic services; viii) research and development services and product development; ix) technical support and maintenance; x) data processing and communication; and xi) business development. The ROH suffers a corporation tax of 10% and a branch profit remittance tax of 15%. A ROH can i) lease office premises but cannot ii) issue sales invoice to Clients' nor iii) sign local legal contracts nor iv) import or export goods;
- 16. To assist our Clients to minimize foreign exchange costs, we offer the payment in SG\$, Euro, Pounds or US\$. Kindly let me know in which currency your Firm prefers to settle our fees and I will send an updated invoice, thank you;
- 17. Depending on our Client business and nationality, the Philippines Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval. However, the Government enjoys ultimate power of approval of ROH registrations and business licenses;
- 18. If required, Healy Consultants will be pleased to assist your firm to secure employee visa approvals. Our fee is US\$3,950 for the first employee, US\$2,950 for the second employee, US\$1,950 for the third employee; and US\$950 per employee thereafter. Our fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;

- 19. Healy Consultants' fees to complete monthly bookkeeping services for our Client is US\$950/month. This fee is an estimate based on the average fees we charge our Clients with up to 3 employees and with minimal transactions. Only after we complete the first 2 months bookkeeping can Healy Consultants accurately advise future monthly book keeping fees. The book keeping fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this task in a timely manner. Healy Consultants fees for monthly VAT filing amounts to US\$250 per month. Our fee to provide your Firm for payroll processing for 3 employees amounts to US\$700 per month;
- 20. As stipulated on our <u>business website</u> and in section 3 of our engagement letter, Healy Consultants will only commence the engagement following i) settlement of our fees and ii) completion and signing of our legal engagement letter;
- 21. Healy Consultants will only incorporate your ROH after 75% of <u>due diligence documentation</u> is received by email. Healy Consultants will only open a ROH bank account after 100% of the Client's original due diligence documentation is received by courier;
