The life of the Representative office is unlimited.

- 12. In accordance with Honduras law there is no minimum share capital requirement for a Honduras representative office. However, the parent company should deposit at least US\$1,250 to the RO corporate bank account. - 13. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients will not have to travel during this engagement.
