 Healy Consultants Group PLC's fees to efficiently and effectively complete Kosovo Branch Office registration within <u>6 weeks</u> by: i) choosing the optimum regulatory license for our Client's business activities; ii) reserving a branch name with <u>Registry of Business Organization and Trade Names</u>; iii) settling our accountant and lawyer fees and iv) preparing a high quality branch registration application for <u>Ministry</u> <u>of Trade and Industry's Business Registration Unit</u>;

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a <u>detailed project plan</u>, mapping out <u>deliverables</u> by week throughout the engagement term;

Healy Consultants Group PLC will act as your Kosovo branch secretary, for which our annual responsibilities include i) preparing and filing the legal annual return; ii) securely maintaining branch records; iii) liaising with the Kosovo government on our Client's behalf; iv) legal filing of changes of branch structure; and v) reminding our Client of statutory deadlines;

In accordance with the Law No. 02/L-123 On Business Organizations, a Kosovo Branch Office shall as from the date of its incorporation have a legal registered office in Kosovo, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Kosovo office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including i) tax letters; ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place <u>Healy Consultants Group</u> PLC's office address on invoices, contracts, websites and business cards;

- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of Government costs include i) reserving the branch name with the <u>Registry of Business Organization and Trade Names</u>; ii) preparation of branch deeds and articles of association; and iii) issuance of the company seal. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
- 4. Healy Consultants Group PLC will be pleased to open a Kosovo branch bank account without our Client travel. It is a time consuming task, and Healy Consultants Group PLC will shelter our Client from the associated administrative challenges. Healy Consultants Group PLC will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Kosovo for branch bank account opening, Healy Consultants Group PLC will refund our Client €950;

Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

Healy Consultants Group PLC will prepare a business plan for the bank to optimize the probability of branch bank account approval. However, the banks enjoy ultimate power of approval of branch bank account applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC's control. - In accordance with <u>Law No. 02/L-123 On Business Organizations</u>, each entity must register for corporate tax and VAT at the <u>Tax Administration of Kosovo</u> if its annual turnover exceeds €50,000;
- 6. For an active trading branch, these <u>accounting and tax</u> fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual branch accounting and tax obligations. Following receipt of a set of draft accounting numbers from your branch, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant branch, Healy Consultants Group PLC fees are only €950;
- 7. All fees quoted in this invoice correspond to fees quoted <u>on Healy Consultants Group PLC's website</u>. Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants Group PLC inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. - In accordance with <u>Law No. 02/L-123 On Business Organizations</u>, there is no issued share capital to be deposited to the branch bank account;
- 12. Branch business activities are limited to those defined by the parent company. A branch does not have a maximum of employees it can employ. The branch suffers a corporation tax of 10%. A branch can i) lease office premises; ii) issue sales invoice to Clients'; and iii) sign local legal contracts. A branch can import and export goods. The life of the branch is unlimited;
- 13. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients' will <u>not</u> have to travel during this engagement. Healy Consultants Group PLC will efficiently and effectively and aggressively complete branch registration and branch bank account opening in a timely manner without our Client presence. Instead, our Client will need to i) sign and get documents legalized in the embassy in their country of origin and ii) courier the originals to Healy Consultants Group PLC's office;



- 14. In accordance with the <u>Law No. 02/L-123 On Business Organizations</u>, each Kosovo Branch Office must have at least one individual country representative ordinarily resident in Kosovo. If required, Healy Consultants Group PLC will be pleased to provide your firm with a professional nominee representative in [country]. Our fee amounts to US\$6,600 per annum;
- 15. If our Client requires non-resident nominee shareholder and director <u>services (click link)</u>, Healy Consultants Group PLC will be pleased to assist. Our fee for professional, passive nominee non-resident corporate shareholder amounts to €2,100 per annum. Our fee to be both non-resident nominee director and shareholder amounts to €6,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants Group PLC to reputation, litigation and financial risk;
- 16. If required, Healy Consultants Group PLC will be pleased to assist your firm secure employee visa approvals. Our fee is €4,950 for the first employee, €3,950 for the second employee, €2,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
- 17. Depending on our Client's business and nationality, the Kosovo Government may require a special regulatory license to carry on your business in the country. Healy Consultants Group PLC will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of branch registrations and business licenses;
- 18. Some of our Clients request Healy Consultants Group PLC to provide temporary shared <u>office space</u> for 6 months until their preferred business premises is found. If your Firm requires this service, our one-time fee is €950. Monthly rental thereafter is paid directly to the landlord, independently of Healy Consultants Group PLC;
- 19. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile. Let us know if you need Healy Consultants Group PLC help to clarify your local and international annual tax reporting obligations;
