Most of our Clients wish to place Healy Consultants Group PLC' office address on invoices, contracts, websites and business cards;
- 3. This fee is an estimate of government costs payable during your Firm's engagement. All government fee payments will be supported by original receipts and invoices. Examples of government costs include i) notarizing the company deeds and articles of association; ii) registering the statutes with the Direction Générale des Impôts (DGI); iii) registering with the Commercial Registry at the <u>Ministry of Commerce and Industry</u> and obtaining the authorization of operations (Droit de fonctionnement); iv) obtaining the Tax ID number (numero d'identification fiscale –NIF) and v) obtaining and legalizing the special commercial books. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
- 4. Healy Consultants Group PLC will be pleased to open a Haiti corporate bank account without our Client needing to travel. - In accordance with Haiti law, each entity must register for corporate tax and VAT at the <u>Directorate</u> <u>General of Taxes</u> (DGI);
- 6. These Healy Consultants Group PLC project management fees relate to time and resources dedicated to:
  - a. thoroughly research and plan license applications for our Client;
  - b. devising strategies to i) minimise the total engagement period, ii) complete the engagement without our Client travelling and iii) ascertain the need for a specific regulatory license;

- 14. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile. Let us know if you need Healy Consultants Group PLC help to clarify your local and international annual tax reporting obligations;
- 15. Depending on our Client's business and nationality, the Indian Government may require a special regulatory license to carry on your business in the country. Healy Consultants Group PLC will assist our Client secure license approval; there may be additional engagement fees. - 18. Monthly, quarterly and mid-year Government tax obligations include monthly and quarterly payroll reporting, VAT and corporation tax return filing. If you need our help, Healy Consultants Group PLC can complete monthly Government reporting for a monthly fee of US\$860. Healy Consultants Group PLC monthly support will include i) receive in dropbox the monthly invoices from our client; ii) label monthly bank statement transactions; iii) preparation and submission of VAT returns and iv) submission of monthly employee payroll reporting;

During the engagement, shareholders and directors documents may need to be translated into the local language before the Government and Bank approves company registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants Group PLC can complete this administrative task;

As always, Healy Consultants Group PLC will negotiate with all third parties to eliminate or reduce additional engagement costs. For transparency purposes, all third party fee payments will be supported by original receipts and invoices.
