Notes to invoice above:

1. Healy Consultants' fees to legally register our Clients' Iraq LLC with Healy Consultants' temporary professional, passive nominee shareholders and directors and bank signatory. Within three weeks (click link), my team and I will email you i) a company registration number ii) a corporate bank account number iii) a city center business address iv) a tax number and iv) a proforma Iraq sales invoice template;

Our fee also includes: i) choosing the optimum regulatory license for our Client's business activities ii) reserving a company name with Ministry of trade (MOT) iii) settling our accountant and lawyer fees and iv) preparing a high quality company incorporation application for MOT;

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees or surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of <u>a detailed project plan</u>, mapping out deliverables by week throughout the engagement term.

- 3. This fee is an estimate of government costs payable during your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include i) Reserving company name at the Ministry of trade (MOT) ii) drafting of the company's articles; iii) obtaining shareholder's tax clearance; iv) obtaining the certificate of incorporation with the companies registry at the MOT, v) registering for social security. Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

 In accordance with <u>Iraq Tax Law</u>, each Iraqi business entity must register for corporate tax and VAT at the <u>General Commission of Tax</u> (GCT);

- 6. In accordance with Iraq Company Law, all Iraq companies must have i) 1 shareholder and ii) 1 director who can be of any nationality. Appointment of Healy Consultants Group PLC professional, passive nominee shareholders and directors and bank signatory enables our Client to i) invoice customers within 4 weeks and ii) sign contracts and lease premises.
 - If required, Healy Consultants will be pleased to provide our Clients with a full package of passive professional nominee services for five months. Our fee is US\$2,750 for this service. Our fee to provide only a country resident director or shareholder is US\$6,600 per annum;
- 7. Following business set up completion, Healy Consultants Group PLC assists our Client appoint their preferred shareholders and directors and the bank signatory. Depending on our Client business and nationality, this process can take up to 4 months;
 - Before the Iraq bank approves our Clients' preferred bank signatory, the bank in-house Legal and Compliance Department will request additional Know Your Customer documents. 

- 9. All fees quoted in this invoice correspond to fees quoted on Healy consultant's <u>business website</u>. Please regarding view this invoice carefully to identify errors. During the rush of a business day, it is possible Healy Consultants inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. In the unfortunate event you identify invoice errors, please revert to me directly re the same. I apologize in advance if I or my staff made invoice errors;
- 10. Assuming our Clients re-engage Healy Consultants in year 2, this fee is an estimate of the fees payable next year, 12 months after the date of company registration;
- 11. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster than expected and more easily than expected, Healy Consultants is happy to refund some fees to our Client;
- 12. In accordance to Iraq <u>Company Law</u>, the minimum share capital of an Iraqi company is US\$850. The paid-up share capital must be deposited prior of company registration date. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our Clients;
- 13. Monthly, quarterly and mid-year Government tax obligations include i) monthly payroll reporting ii) monthly VAT reporting; iii) monthly or quarterly corporation tax return filing. If you need our help, Healy Consultants can complete monthly Government reporting for a monthly fee of US\$960. Healy Consultants monthly support will include i) receive in dropbox the monthly invoices from our client ii) label monthly bank statement transactions iii) preparation and submission of VAT returns and iv) monitor monthly profit levels to minimize annual tax v) submission of monthly employee payroll reporting;

During the engagement, shareholders and directors documents may need to be translated into the local language before the Government and Bank approves company registration and corporate bank account opening respectively.
