In accordance with the <u>Malaysian Companies Act 1965</u>, a Company shall as from the date of its incorporation have a legal registered office in Malaysia, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC Malaysia business office will be the registered office address for your Malaysia Company. Thereafter, this address will be used to receive Government correspondence including i) annual and quarterly tax returns; ii) bank statements and iii) employee payroll tax and pension correspondence. Most of our Clients wish to place <u>Healy Consultants Group PLC's office address</u> on invoices, contracts, websites and business cards;

- 3. This fee is an estimate of Government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include i) reserving the company name with the Companies Commission (<u>SSM</u>); ii) obtain the certificate of incorporation with the Companies Commission (<u>CCM</u>); iii) sign up with inland revenue department and iv) apply for business license. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
- 4. Healy Consultants Group PLC will be pleased to open a Malaysia corporate bank account without travel. For a company trading products with Malaysia retail and wholesale customers, this fee includes preparation of a quality Wholesale, Retail Trade (WRT) License application and submission of the same to the <u>Ministry of Domestic Trade, Co-operatives and Consumerism</u> (MDTCC). The MDTCC will be required by our Client to i) legally own more than 51% of the shares of his Malaysia subsidiary and ii) deposit a minimum paid up capital of RM 1 million (Approx. US\$226,000);

The challenges and timeframes required to secure Government approval will significantly vary according to the nature of the business and the nationality of our Client. If during the engagement, Healy Consultants Group PLC realizes that the WRT license required by our Client is more complex to secure than anticipated, requiring a large additional investment of resources and time, our Firm can revert to request additional fees. If Healy Consultants Group PLC completes the engagement faster and more easily than expected, our Firm will be happy to refund some fees to our Client;

 Healy Consultants Group PLC will be pleased to assist your firm secure <u>visa approvals</u> (click link) in Malaysia. Our fee is US\$4,950 per employee. 7. In accordance with the <u>Malaysian Companies Act 2016</u> effective from 31 January 2017, every Malaysian Company shall have at least one director who are ordinarily resident in Malaysia. Most of our Clients request Healy Consultants Group PLC to provide passive, <u>professional resident director</u>, which will increase the probability of successful visa approval and corporate bank account opening. If our Client requires nominee individual director services amount to US\$3,350 per director per annum;



8. After the company is fully registered it is neccesary to register the company with the <u>Inland Revenue Board</u> (LHDN) as a tax payer;

A Malaysian company is also obliged to register for SST if annual sales exceed or are expected to exceed US\$140,000 (equivalent to RM500,000) in any calendar year. Healy Consultants Group PLC fee is US\$950 to register with the <u>Malaysia tax department</u>;

- 9. For an active trading company, these <u>accounting</u>, <u>audit and tax</u> fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. As per <u>subsection 267(2) of the Companies</u> <u>Act 2016</u>, all private companies need to appoint an auditor in each financial year. Consequently, our fees to complete the annual accounting and tax filing obligations of a Malaysia company reflect this extra audit cost. For a dormant company, Healy Consultants Group PLC fees are only US\$950;
- 10. All fees quoted in this invoice correspond to fees quoted <u>on Healy Consultants Group PLC's website</u>. Please review this invoice carefully to identify errors. If the Client wishes to apply for i) work permit for expatriate and ii) secure Wholesale, Retail Trade (WRT) License, the issued share capital must be increased to U\$226,000 (equivalent to RM1million). To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these funds on behalf of our clients;

During the engagement, shareholders and directors' documents may need to be translated into the local language; before the Government and Bank approves company registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants Group PLC can complete this administrative task;
