- 3. This fee is an estimate of government costs payable during your Firm's engagement. All government fee payments will be supported by original receipts and invoices. Examples of government costs include i) reserving the partnership name with the <u>CDE</u> ii) registering the partnership with the CDE and iii) publishing the notice of the partnership formation in the <u>legal journal</u>. - In accordance with Gabon tax regulations, each entity must register for corporate tax and VAT at the <u>Direction Générale des impôts - Gabon</u> (DGI). Healy Consultants Group PLC will be happy to assist you with tax and VAT registration for a one time fee of US\$750;
- 6. For an active trading partnership, these <u>accounting and tax</u> fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual partnership accounting and tax obligations. Following receipt of a set of draft accounting numbers from your partnership, Healy Consultants Group PLC will more accurately advise accounting and tax fees. - 12. Depending on our Client business and nationality, the Government may require a special regulatory license to carry on your business in the country. Healy Consultants Group PLC will assist our Client secure license approval. There may be additional fees for this service;
- 13. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients' will <u>not</u> have to travel during this engagement. Healy Consultants Group PLC will efficiently and effectively and aggressively complete partnership registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to i) sign and get documents legalized in the embassy in their country of origin and ii) courier the originals to Healy Consultants Group PLC office;


