1. Healy Consultants Group PLC's fees to supply our Client a dormant clean Korean shelf company Bixion Technology Co., Ltd. All Government fees paid up to date and historic annual accounting and tax and legal and audit obligations complete. Within 1 business day after fee settlement, my team and I will email you **i)** a certificate of incorporation and **ii)** a city center business address **iii)** a tax number **iv)** a Korean multicurrency corporate bank account numbers and **v)** a proforma Korea LLC sales invoice template on your company letterhead, complying with Korean company law ([click link](#));

All [engagement fees](#) are agreed and paid up front and agree to the fees published on our Korea web pages. Consequently, there are no hidden fees or surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of [a detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term.

Every week during the engagement, Healy Consultants Group PLC emails our Client a detailed engagement [status update](#). Our Client is immediately informed of engagement problems and solutions and progress. In accordance with Korean regulations, a Korea company shall as from the date of its incorporation have a legal registered office in Korea, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC will supply a Korea commercial address to be the registered office address for your Korean company. Thereafter, this address will be used to receive Government correspondence including **i)** annual tax returns **ii)** bank statements **iii)** employee payroll tax and pension correspondence. Most of our Clients wish to place Healy Consultants Group PLC's [Korea office address \(click link\)](#) on invoices, contracts, websites and business cards;

Before company incorporation is completed, the Korean Government must review and approve a lease agreement for office premises. The lease agreement provides our Client an unoccupied desk space of 5 sqm for US\$2,510 per year. A dormant Korean shelf company must annually maintain a physical office. During the change of corporate structure process, the Korean Government may re-inspect the physical office. If our Client wishes to place an employee in this office space, additional costs will apply. Our Client should budget to pay the Korean Landlord an annual rental of US\$6,000 per annum;

3. This fee is an estimate of Government costs payable during the engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include **i)** company change of corporate structure fees payable to [Start-Biz](#) **ii)** Public Health Insurance Program fees and **iii)** issuance of new corporate documents reflecting the change of directors and shareholders. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
4. Over coming days, Healy Consultants Group PLC will supply our Client with a bank statement that shows **i)** multi-currency corporate bank account numbers and **ii)** evidence the multi-currency corporate bank account was dormant since inception and **iii)** proof of the initial deposit and current bank balance. It is important our Client is aware Healy Consultants Group PLC will only change the bank signatory after 100% of our Client due diligence documentation is received by courier. Only after the sole bank signatory is legally changed to our Client, can you remit funds into the corporate bank account.;

Furthermore, global banks now require evidence of proof of business in the country where the holders of the corporate bank account are residing, including sales contracts, invoices and lease agreement;

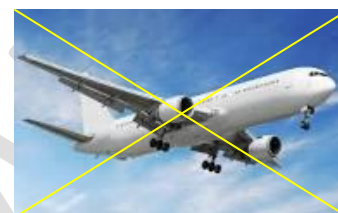

12. If required, Healy Consultants Group PLC will be pleased to assist your firm to secure [visa](#) approvals. Our fee is US\$5,950 for the first employee, US\$4,950 for the second employee, US\$3,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC's control. 13. Depending on our Client business and nationality, the Korean Government may require a special regulatory license to carry on your business in the country. Healy Consultants Group PLC will assist our Client secure license approval. There may be additional fees for this service. However, the Government enjoys ultimate power of approval of company corporate structure changes and business licenses;
14. If our Client requires nominee shareholder and director [services \(click link\)](#), Healy Consultants Group PLC will be pleased to assist.
