In accordance with <u>Dominica Companies Act 1994</u>, a Dominica shall as from the date of its incorporation have a legal registered office in Dominica, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC's Dominica office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including i) tax letters; ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place <u>Healy Consultants Group PLC's office address</u> on invoices, contracts, websites and business cards;

- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices.
