Thereafter, this address will be used to receive government correspondence including i) tax letters ii) notice of the legal annual return and iii) all government communications. Most of our Clients wish to place <u>Healy Consultants' office address</u> on invoices, contracts, websites and business cards.
- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include i) company registration fees ii) company name reservation fees and iii) company seal and accounting book ordering fees. Following engagement completion, Healy Consultants will refund our Client any excess funds received over actual government costs paid.
- 4. In accordance with El Salvador laws, each entity must register for corporate tax and VAT at the Ministry of Finance.
- 5. Healy Consultants will be pleased to open an El Salvador Bitcoin-friendly corporate bank account without our Client needing to travel. It is a time consuming task, but Healy Consultants will shelter our Client from the associated administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval for a newly-formed company when shareholders, directors and bank signatories reside overseas. Depending on our Client's business and nationality, there is a 20% possibility the banks will request a bank signatory to travel for a one-hour bank interview.

- **12.** In accordance with El Salvador <u>Commercial Code article 106</u>, the minimum issued share capital of a limited liability company is US\$2,000. 5% of the amount must be deposited to the company bank

account before company incorporation, while the remaining 95% can be injected within one year after company formation. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our clients.

- 13. In accordance with El Salvador Laws, each limited liability company must have at least one individual director ordinarily resident in El Salvador, locally known as the <u>legal representative</u>. If required, Healy Consultants will be pleased to provide your firm with a professional nominee director in El Salvador. Our fee amounts to US\$6,600 per annum.
- 14. If our Client and Healy Consultants properly plan this engagement, our Clients' will <u>not</u> have to travel during this engagement. Healy Consultants will efficiently complete company registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to i) sign and get documents legalized in the embassy in their country of origin and ii) courier the originals to Healy Consultants office.



- 15. Depending on our Client's business and nationality, the Salvadorian Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of company registrations and business licenses.
- 16. If our Client requires nominee non-resident shareholder and director <u>services</u>, Healy Consultants will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee non-resident director and shareholder amounts to US\$6,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants to reputation, litigation and financial risk.
- 17. If required, Healy Consultants will be pleased to assist your firm to secure employee visa approvals. Our fee is US\$2,950 for the first employee, US\$1,950 for the second employee, US\$950 per employee thereafter.
